The State Secretariat of Civil Aviation (SSCA) of the Kingdom of Cambodia presents its compliment to all local airlines of Cambodia, foreign airlines, and commercial private jets (air operators) operating into and out of Phnom Penh, Siem Reap, and Preah Sihanouk International Airports (PNH/REP/KOS) and would like to update the latter on the pricing policy for COVID-19 test, quarantine, and treatment services to foreign travelers entering to Cambodia at public hospital, as follows:

*In reference to Ministry of Health's Notice dated 11 June 2020, the pricing policy and fees charged for COVID-19 test, quarantine and treatment services to foreign travellers entering to Cambodia at public hospital are as follows:*

*1. The details of the services price are as follow:*

*1. Payment fees for foreign travellers arriving in Cambodia while waiting the result of COVID-19 test is released*

1	Transport from airport to designated hotel or quarantine centers	5/person/one way
2	COVID-19 Test (Collection and sending specimen, laboratory and result)	100/time/person
3	Designated Hotels and quarantine Centers	30/day/person
4	3 times meals (Breakfast, lunch, and dinner)	30/day/person

*2. Payment fees for 14-day quarantine at designated hotels or quarantine centers of negative COVID-19 travelers the same flight or the same mean of transports with a positive passenger*

1	Transport	5/person/one way
2	Designated Hotels and quarantine Centers	30/day/person
3	COVID-19 Test (Collection and sending specimen, laboratory and result)	100/time/person
4	3 times meals (Breakfast, lunch and dinner)	30/day/person
5	Laundry and cleaning services	15/day/person
6	Medical services (3 health staff for period of quarantine in each center)	6/day/person
7	Security services (2 persons)	3/day/person




3. Payment fees for consultation and treatment positive COVID-19 patient in public hospitals

1	Transport	5/person/one way
2	COVID-19 Test (4 times minimum)	100/person/time
3	Room charge in hospital	30/day/person
4	Treatment fee including medicines	150(maximum)/day/person
5	3 times meals (Breakfast, lunch and dinner)	30/day/person
6	Laundry service	15/day/person
7	Emergency	Follow the existing fee tariff of hospital
8	Consultation and treatment of existing chronic diseases of COVID-19 patient	Follow the existing fee tariff of hospital
9	Funeral	1500/person

4. Health Certificate for COVID-19

2	Issue Health Certificate	30/person/time

- II. Upon their arrival in Cambodia, all foreign nationals must provide proof of Health Insurance Documents with a minimum medical coverage of not less than US\$ 50, 000 (fifty thousand US dollars) and must make deposits, by cash or credit card, of US\$ 3, 000 (three thousand US dollars) with the designated commercial banks present at the point of entry. This deposits will be deducted for payments on services during the implementation of health measures.
- III. For clarification, this NOTICE (Revision 06-A: 16 June 2020) is issued in supplement to the NOTICE (Revision 6: 09 June 2020), which shall still be in force.
